2. DISCUSSION OF ADDING MORE SPECIES OF TREES TO THE CITY RELEAF PROGRAM

-Current Approved Species of Trees:

- Chanticleer Flowering Pear
- Autumn Blaze Flowering Pear
- Prairiefire Flowering Crab
- American Linden
- Triumph Elm
- Autumn Blaze
- Swamp White Oak
- Sawtooth Oak
- Northern Red Oak
- Red Sunset Maple
- Miyabe Maple

On January 14th 2020, 11 trees were added to the approved species of trees to the City Releaf Program. The discussion of adding additional trees to the Releaf Program were discussed. Below are highlights around the discussion of adding more tree species to the Releaf Program:

- Mike Oneby had noted that the city has many new tree projects coming in the very near future and would like to get new species approved before the projects begin.
- Lists of approved street trees from surrounding communities were distributed to those present at the meeting.
- Individuals present at the meeting were told to come up with lists of trees that they recommend and do not recommend to be added to the City's Releaf Program. These tree species would then be discussed at the next meeting which will take place November 10th, 2020.

3. DISCUSSION OF ASH TREE BORER

The board continued the discussion of the Emerald Ash Borer (EAB) from the Special Tree Board Meeting that was held September 8th, 2020. Below are highlights of the discussion around the EAB.

- Brent Peterson had noted that the survey of City property to see how many ash trees are within the city of Seward had not yet been completed. The results of the survey will be presented at the next meeting.
- Brent Peterson also noted that there had been an article in the Seward County Independent regarding the Emerald Ash Borer.
- There is now a ban on cutting firewood from the burn pile to take home for personal use as this can increase the spread of the EAB. You are still able to take your Ash Tree wood and other wood to the burn pile to burn, there is just no removal from the City's burn pile.
- Charles Matzke recommended bringing in someone from Lincoln or a surrounding community to learn about their plans in slowing and stopping the spread of the EAB. Thomas Suhr will be looking into other communities plans of action.
- The older areas of Seward, which includes the downtown area have the highest populations of Ash trees in the community.

- Mike Oneby mentioned that ash trees are able to be treated for EAB. The treatment would need to be applied by a certified arborist every 2 years and the cost is determined per inch in diameter.
