Sitting Vice President Jan Matzke call the meeting to order. Matzke also mentioned that a copy of the Open Meetings Act is posted in Room Three (south wall) for public inspection.

- 2. MANAGER'S REPORT Erin Wiseman

Wiseman reported that the roofing project went well. There is a bit of work to be finished. Next project is the installation of HVAC Units for auditorium. It has also been mentioned that the boiler is going to need a decision made as well, Lee's Refrigeration says there is nothing more they can do for the boiler. In addition to the HVAC issues, Wiseman reported the plumbing issues in the lower level. There have been times the sewer has backed up. Wiseman noted that a clear and defined set of rules and policies regarding the use of the building is becoming necessary.
