#### **Programs**

Staff requests permission to close the library at 11:30 a.m. so that all participants may adjourn to the blocked off parking lot to view the event, which reaches maximum coverage here at 11:45 a.m. Staff does have eclipse glasses to hand out as they are required for safe viewing. Special adult craft classes will be held once a month in October, November and December. The October session is getting a lot of interest already.

To honor being in this building for 20 years, we welcome Craig Johnson this Sunday at 2:00. In addition to this outstanding program, three Nebraska authors (Alex Kava, Tosca Lee and Lydia Kang) will be here on October 22, also at 2:00. These programs will conclude the 20th anniversary celebration of 2023.

This month's book group members will meet jointly in honor of October being National Reading Group month. The meeting will be held during the Reader's Choice normal time – October 9 at 7:00 p.m. and we will be reading The Memory of Running by Ron McLarty. R&R continues to discuss current books read and will meet on October 12.

#### Operations:

Staff is working on still serving our patrons who need it, but hopefully it will be functioning again by this Sunday when we have a major program happening.
